



Thus, the basic pension will be Rs.77,950. If the employee is appointed on contract basis, the remuneration shall be fixed at Rs. 77,950 (Rs.1,55,900-Rs.77,950). An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. However, retired employees engaged as Consultants may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.</p>
